DIRECTORS' REPORT

for the financial period ended 4 April 2025

The directors present their report and the audited financial statements for the financial period ended 4 April 2025.

Principal Activity and Review of the Business

The principal activity of the company during the year was the provision of a community employment scheme supported and monitored by the DSP. This is a non profit making organisation and the directors are satisfied with the results achieved this year.

The Company is limited by guarantee not having a share capital.

There has been no significant change in these activities during the financial period ended 4 April 2025.

Principal Risks and Uncertainties

The directors consider the principal risks and uncertainties the company would face is the lack of government funding and the potential increase in compliance requirements in accordance with the company, health and safety and other legislation. The company mitigates these risks by continually monitoring the levels of activity, its budgets, targets and projections. The company closely monitors emerging changes to regulations and legislation on an ongoing basis.

Financial Results

The surplus/(deficit) for the financial period amounted to €15 (2024 - €(4)).

At the end of the financial period, the company has assets of €105,477 (2024 - €99,348) and liabilities of €105,403 (2024 - €99,289). The net assets of the company have increased by €15.

INDEPENDENT AUDITOR'S REPORT

to the Members of St Josephs Development Group CLG

Report on the audit of the financial statements

Opinion

We have audited the financial statements of St Josephs Development Group CLG ('the company') for the financial period ended 4 April 2025 which comprise the Income and Expenditure Account, the Balance Sheet, the Reconciliation of Members' Funds, the Cash Flow Statement and the related notes to the financial statements, including the summary of significant accounting policies set out in note 2. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued in the United Kingdom by the Financial Reporting Council.

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 4 April 2025 and of its surplus for the financial period then ended;
- have been properly prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland"; and
- have been properly prepared in accordance with the requirements of the Companies Act 2014.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (Ireland) (ISAs (Ireland)) and applicable law. Our responsibilities under those standards are described below in the Auditor's responsibilities for the audit of the financial statements section of our report. We are independent of the company in accordance with the ethical requirements that are relevant to our audit of financial statements in Ireland, including the Ethical Standard for Auditors (Ireland) issued by the Irish Auditing and Accounting Supervisory Authority (IAASA), and we have fulfilled our other ethical responsibilities in accordance with these requirements. As part of an audit in accordance with ISAs (Ireland), we exercise professional judgement and maintain professional scepticism throughout the audit. We also:



NOTES TO THE FINANCIAL STATEMENTS

for the financial period ended 4 April 2025

1. General Information

St Josephs Development Group CLG is a company limited by guarantee incorporated and registered in Ireland. The registered number of the company is 339643. The registered office of the company is O'Hanlon Park, Dundalk, Co. Louth which is also the principal place of business of the company. The nature of the company's operations and its principal activities are set out in the Directors' Report. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the financial period ended 4 April 2025 have been prepared on the going concern basis and in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102).

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial period, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014.

Income

Income is the total amount of grants received or receivable from the Department of Social Protection during the period.

Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

Government grants

Capital grants received and receivable are treated as deferred income and amortised to the Income and Expenditure Account annually over the useful economic life of the asset to which it relates. Revenue grants are credited to the Income and Expenditure Account when received.

Foreign currencies

Monetary assets and liabilities denominated in foreign currencies are translated at the rates of exchange ruling at the Balance Sheet date. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated at the rates of exchange ruling at the date of the transaction. Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. The resulting exchange differences are dealt with in the Income and Expenditure Account.

3. Period of financial statements

The financial statements are for the 11 month 30 days period ended 4 April 2025.

4. Departure from Companies Act 2014 Presentation

The directors have elected to present an Income and Expenditure Account instead of a Profit and Loss Account in these financial statements as this company is a not-for-profit entity.
