DIRECTORS' RESPONSIBILITIES STATEMENT

for the financial year ended 31 December 2024

The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable Irish law and regulations.

We have audited the financial statements of New Street Mall Management Limited ('the company') for the financial year ended 31 December 2024 which comprise the Profit and Loss Account, the Balance Sheet, the Statement of Changes in Equity and the related notes to the financial statements, including the summary of significant accounting policies set out in note 2. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued in the United Kingdom by the Financial Reporting Council.

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 31 December 2024 and of its loss for the financial year then ended;

NOTES TO THE ABRIDGED FINANCIAL STATEMENTS

for the financial year ended 31 December 2024

1. General Information

New Street Mall Management Limited is a company limited by shares incorporated and registered in Ireland. The registered number of the company is 127478. The registered office of the company is Unit 25,, Estuary House,, New Street,, Malahide, Co Dublin, Ireland. The principal activity of the company is the managing of the New Street Mall Shopping Centre, New Street, Malahide, Co. Dublin. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the financial year ended 31 December 2024 have been prepared on the going concern basis and in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102).

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014.

Cash flow statement

The company has availed of the exemption in FRS 102 from the requirement to prepare a Statement of Cash Flows because it is classified as a small company.

Turnover

Turnover comprises of service charges received.

Trade and other debtors

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

Taxation

Current tax represents the amount expected to be paid or recovered in respect of taxable income for the financial year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Balance Sheet date. The tax status of the company is that its' activities are deemed "mutual activities" by the tax authorities, which are not taxable. The company however, does pay tax on deposit interest when the tax liability exceeds €32 and on any third party income earned. The company at present, does not hold any deposit account.

Sinking Fund Contributions

In accordance with Section 19 of the Multi - Unit Developments Act 2011, the company must establish a sinking fund to fund non-routine maintenance and other non-routine costs that may arise from time to time. The Sinking Fund is not guaranteed to cover all unexpected costs of a non-recurring nature. These funds are held in a separate designated bank account and are allocated to a special reserve titled "sinking fund reserve". This requirement does not apply to wholly commercial developments, which is the case for New Street Mall Management Company Limited, all units in the development are commercial units.

Ordinary share capital

The ordinary share capital of the company is presented as equity.

3. Common areas and location

The common areas in the development have been vested in New Street Mall Management Limited.

4. Service Charges

The total income of the company for the year was derived from its principal activity wholly undertaken in Ireland.

There are 26 commercial units from which the company is entitled to receive service charges with aggregate service charges billed for the year of €64,252 (2023: €64,252).

5. Insurance

The insured value of the multi-unit development in 2024 was €9,483,075, the amount of the insurance premium (including Government levy at 5%) was €7,774 and the insurance company is AXA Insurance dac. The principal risks covered are: Property Damage, Business Interruption, Employers Liability and Property Owners Liability.

6. Employees

The average monthly number of employees, including directors, during the financial year was 0, (2023 - 0).
