



**Report on the audit of the financial statements**

***Opinion***

We have audited the financial statements of Gillsland Limited ('the Company') for the year ended 31 March 2025 set out on pages 8 to 14, which comprise the profit and loss account and other comprehensive income, the balance sheet, the statement of changes in equity and related notes, including the material accounting policies set out in note 3. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 101 Reduced Disclosure Framework issued in the United Kingdom by the Financial Reporting Council.

In our opinion:

- the financial statements give a true and fair view of the assets, liabilities and financial position of the Company as at 31 March 2025 and of its result for the year then ended;
- the financial statements have been properly prepared in accordance with FRS 101 Reduced Disclosure Framework; and
- the financial statements have been properly prepared in accordance with the requirements of the Companies Act 2014.

***Basis for opinion***

### **1 Reporting entity**

Gillsland Limited (the “company”) is a private limited by shares and company incorporated, domiciled and registered in Ireland. The Company’s registered number is 97876 and the address of its registered office is Unit 21, Fonthill Business Park, Fonthill Road, Yellow Walls, Lucan, Dublin, D22 FR82.

### **2 Statement of compliance**

These financial statements were prepared in accordance with Financial Reporting Standard 101 *Reduced Disclosure Framework (“FRS 101”)*. There have been no material departures from the Standards.

In preparing these financial statements, the company applies the recognition, measurement and disclosure requirements of International Financial Reporting Standards as adopted by the EU (“Adopted IFRSs”), but makes amendments where necessary in order to comply with the Companies Act 2014 and has set out below where advantage of the FRS 101 disclosure exemptions has been taken.

The company’s ultimate parent undertaking, DCC plc, includes the company in its consolidated financial statements. The consolidated financial statements of DCC plc are prepared in accordance with International Financial Reporting Standards as adopted by the European Union and are available to the public and may be obtained from DCC House, Leopardstown Road, Foxrock, Dublin 18, Ireland.

In these financial statements, the company has applied the exemptions available under FRS 101 in respect of the following disclosures:

- Cash Flow Statement and related notes;
- Comparative period reconciliations for share capital;
- Disclosures in respect of capital management;
- The effects of new but not yet effective IFRSs; and
- Disclosures in respect of the compensation of Key Management Personnel.

No judgements have been made by the directors, in the application of these accounting policies that have a significant effect on the financial statements and there are no estimates with a significant risk of material adjustment in the next year.

### **3 Material accounting policies**

#### **3.1 Measurement convention**

The financial statements are prepared on the historical cost basis.

#### **3.2 Basis of preparation**

The financial statements have been prepared on a going concern basis. The presentation currency used in the financial statements is Euro, being the functional currency of the company.

#### **3.3 Foreign currency**

Assets and liabilities denominated in foreign currencies are translated into Euro at the exchange rates ruling at the balance sheet date or at contracted rates where appropriate.

Profits and losses arising on transactions in foreign currencies during the year are included in the profit and loss account at the exchange rate ruling at the date of the transactions.

#### **3.4 Share Capital**

Ordinary shares are classified as equity.

#### **3.5 Non-derivative financial instruments**

Non-derivative financial instruments comprise trade and other debtors

Trade and other debtors are recognised initially at fair value. Subsequent to initial recognition they are measured at amortised cost using the effective interest method, less any impairment losses. If payments received from customers exceed the income recognised, then the difference is posted as deferred income.

### **7 Ultimate parent company**

The directors regard DCC plc as the ultimate holding company. The largest and smallest group in which the results of the company are consolidated is that headed by DCC plc. ### **8 Related party disclosures**
