



Report on the audit of the financial statements

Opinion

We have audited the financial statements of A1 Games Distribution Unlimited Company ('the Company') for the year ended 31 March 2025 set out on pages 8 to 14, which comprise the profit and loss account and other comprehensive income, the balance sheet, the statement of changes in equity and related notes, including the material accounting policies set out in note 3. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 101 Reduced Disclosure Framework issued in the United Kingdom by the Financial Reporting Council.

These financial statements have not been prepared on the going concern basis for the reason set out in note 3.

In our opinion:



1 Reporting Entity

A1 Games Distribution Unlimited Company (the "Company") is a private unlimited company and incorporated, domiciled and registered in Ireland. The Company's registered number is 466550 and the address of its registered office is Unit 21, Fonthill Business Park, Fonthill Road, Yellow Walls, Lucan, Dublin, D22 FR82.

2 Statement of compliance

These financial statements were prepared in accordance with Financial Reporting Standard 101 *Reduced Disclosure Framework ("FRS 101")*.

In preparing these financial statements, the Company applies the recognition, measurement and disclosure requirements of International Financial Reporting Standards as adopted by the EU ("Adopted IFRSs"), but makes amendments where necessary in order to comply with the Companies Act 2014 and has set out below where advantage of the FRS 101 disclosure exemptions has been taken.

The Company's ultimate parent undertaking, DCC plc, includes the Company in its consolidated financial statements. The consolidated financial statements of DCC plc are prepared in accordance with International Financial Reporting Standards as adopted by the European Union. These are available to the public and may be obtained from DCC House, Leopardstown Road, Foxrock, Dublin 18, Ireland.

In these financial statements, the Company has applied the exemptions available under FRS 101 in respect of the following disclosures:

- Cash Flow Statement and related notes;
- Comparative period reconciliations for share capital;
- Disclosures in respect of capital management;
- The effects of new but not yet effective IFRSs; and
- Disclosures in respect of the compensation of Key Management Personnel.

No judgements have been made by the Directors, in the application of these accounting policies that have a significant effect on the financial statements and there are no estimates with a significant risk of material adjustment in the next year.

3 Material accounting policies

3.1 Measurement convention

The financial statements are prepared on the historical cost basis.

3.2 Basis of preparation

The directors do not expect the Company to trade in the future and it is expected that the Company will be wound up in an orderly manner in due course. Accordingly, these financial statements have been prepared on a non-going concern basis of accounting. All assets are stated at their recoverable amounts. The presentation currency used in the financial statements is Euro being the functional currency of the company.

3 Material accounting policies *(continued)*

3.3 Foreign currency

Assets and liabilities denominated in foreign currencies are translated into Euro at the exchange rates ruling at the balance sheet date or at contracted rates where appropriate.

Profits and losses arising on transactions in foreign currencies during the year are included in the profit and loss account at the exchange rate ruling at the date of the transactions.

3.4 Classification of financial instruments issued by the Company

In accordance with IAS 32, financial instruments issued by the Company are treated as equity only to the extent that they meet the following conditions:

- (a) they include no contractual obligations upon the Company to deliver cash or another financial asset or to exchange financial assets or liabilities with another party under conditions that are potentially unfavourable to the Company; and,
- (b) where the instrument will or may be settled in the Company's own equity instruments, it is either a non-derivative that includes no obligation to deliver a variable number of the Company's own equity instruments or is a derivative that will be settled by the Company exchanging a fixed amount of cash or other financial asset for a fixed number of its own equity instruments.

To the extent that this definition is not met, the proceeds of issue are classified as a financial liability.

3.5 Share Capital

Ordinary shares are classified as equity.

3.6 Non-derivative financial instruments

Non-derivative financial instruments comprise trade and other debtors.

IFRS 9 Financial Instruments:

Trade and other debtors

Trade and other debtors are recognised initially at fair value. Subsequent to initial recognition they are measured at amortised cost using the effective interest method, less any impairment losses. If payments received from customers exceed the income recognised, then the difference is posted as deferred income.
