## NOTES TO THE ABRIDGED FINANCIAL STATEMENTS FOR THE YEAR ENDED 31<sup>st</sup> August 2025

### 1. ACCOUNTING POLICIES

The following accounting policies have been applied consistently in dealing with items which are Considered material in relation to the company's financial statements

#### 1.1. Basis of Accounting

The Statutory financial statements have been prepared under the historical cost convention and comply with the accounting standards issued by the Financial reporting Council, specifically Financial Reporting Standard 105- 'The Financial Reporting Standard applicable to the Micro- entities Regime' (FRS 105). This is the first year in which the financial statements have been prepared under FRS 105.

#### 1.2. Cash Flow Statement

The company meets the size criteria for a small company set out by section 350 of the Companies Act 2014 and therefore in accordance with FRS105: Cash Flow Statements it has not prepared a cash flow statement

#### 1.3. Turnover

Turnover represents the total invoice value, excluding value added tax, of sales made during the year

#### 1.4. Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less accumulated depreciation.

Depreciation is provided at rates calculated to write off the cost less residual value of each asset over its expected useful life, as follows:

Plant & Machinery	-	12.5% Straight Line
Motor Vehicles	-	12.5% Straight Line

#### 1.5. Stock & Work In Progress

Stocks are valued at the lower of cost and net realisable value. Full provision has been made for damaged, deteriorated, obsolescent or unusable materials. In the case of Finished Goods work in progress, cost is defined as the aggregate cost of raw material, direct labour and attributable proportion of direct production overheads.

Net realisable value comprises the actual or estimated selling price less all further costs to completion or to be incurred in marketing, selling and distribution.

#### 1.6. Taxation

The charge for taxation is based on profits for the year and is calculated with reference to the tax rates applying at the balance sheet date.

Current tax is provided at amounts expected to be paid or recovered using the tax rates and laws that have been enacted or substantially enacted by the balance sheet date.

Deferred taxation is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events that result in an obligation to pay more tax in the future or a right to pay less tax in the future have occurred at the balance sheet date. Provisions is made at the rates expected to apply when the timing difference reverse. Timing Differences are differences between taxable profits and results in the financial statements that arise from the inclusion of gains and losses in tax assessments in periods different from those, which there are in the financial statements

A net deferred tax asset is regarded as recoverable and therefore recognised only when, on the basis of all the evidence, it can be regarded as more likely than not that there will be suitable tax profits from which the future reversal of the underlying timing differences can be deducted.
