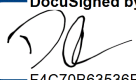

NOTES TO FINANCIAL STATEMENTS

1 FORMATION AND ACTIVITIES

Pittsburgh Steelers Limited (the Company) is an Irish company formed on 20 November 2023. It is a wholly owned subsidiary of PSSI Stadium LLC, a U.S. limited liability company. PSSI Stadium LLC is a single-member LLC and an indirect wholly owned subsidiary of Pittsburgh Steelers Sports Holdco LLC. Pittsburgh Steelers Sports Holdco LLC is a U.S. limited liability company that is treated as a partnership for tax purposes.

Pittsburgh Steelers Limited is intended to conduct all business of the Pittsburgh Steelers football organization that occurs in Ireland and other European Union countries. These activities generally include events and activities such as watch parties, football clinics, and youth and flag football.

Since the Company's formation, PSSI Stadium LLC has been working to establish the appropriate agreements to enable business to be conducted in the name of Pittsburgh Steelers Limited. No transactions have occurred since the Company's formation, other than its initial capitalization,

The Company has no employees and expects to conduct its business using contractors.

2 BASIS OF PREPARATION

Pittsburgh Steelers Limited's financial statements were authorized for issue by the directors of the Company on 7 January 2026, in accordance with FRS 102.

3 FINANCIAL COMMITMENTS, GUARANTEES AND CONTINGENCIES

The Company has no financial commitments, guarantees, or contingencies at 31 March 2025.
