Opinion

1. General Information

Superior Pipeline Products Limited is a company limited by shares incorporated in Ireland. 18 Loughminane Green, Kildare Town, Co. Kildare is the registered office. The principal place of business of the company is Unit 6/7 Osberstown Industrial Park, Osberstown, Naas, Co Kildare. The nature of the company's operations and its principal activities are set out in the Director's Report. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the year ended 31 December 2025 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" Section 1A, issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1A of FRS 102.

Turnover

Turnover comprises the transaction value of the invoice value of goods supplied by the company, received and receivable, exclusive of trade discounts and value added tax.

Tangible assets and depreciation

Tangible assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible assets, less their estimated residual value, over their expected useful lives as follows:

Short leasehold property	-	30% Straight line
Plant and machinery	-	30% straight line
Fixtures, fittings and equipment	-	30% straight line

The carrying values of tangible fixed assets are reviewed annually for impairment in periods if events or changes in circumstances indicate the carrying value may not be recoverable.

Stocks

Stocks are valued at the lower of cost and estimated selling price less costs to complete and sell. Cost comprises expenditure incurred in the normal course of business in bringing stocks to their present location and condition. Full provision is made for obsolete and slow moving items.

Trade and other debtors

Trade and other debtors are initially recognised at transaction value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and in hand, demand deposits with banks and other short-term highly liquid investments with original maturities of three months or less and bank overdrafts. In the Balance Sheet bank overdrafts are shown within Creditors.

Trade and other creditors

Trade and other creditors are initially recognised at transaction value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

Employee benefits

The company operates a defined contribution pension scheme. The assets of the scheme are held separately from those of the company in an independently administered fund.

Taxation and deferred taxation

Current tax represents the amount expected to be paid or recovered in respect of taxable profits for the financial year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Balance Sheet date.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at that date that will result in an obligation to pay more tax in the future, or a right to pay less tax in the future. Timing differences are temporary differences between the company's taxable profits and its results as stated in the financial statements.

Deferred tax is measured on an undiscounted basis at the tax rates that are anticipated to apply in the periods in which the timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

Foreign currencies

Monetary assets and liabilities denominated in foreign currencies are translated at the rates of exchange ruling at the Balance Sheet date. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated at the rates of exchange ruling at the date of the transaction. Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. The resulting exchange differences are dealt with in the Profit and Loss Account.

Ordinary share capital

The ordinary share capital of the company is presented as equity.

3. Provisions Available for Audits of Small Entities

In common with many other businesses of our size and nature, we use our auditors to prepare and submit tax returns to the Revenue and to assist with the preparation of the financial statements.

14. Related party transactions

James O'Reilly is a director and controlling interest in the parent company Superior Pipeline GHC Limited, a company registered in the Republic of Ireland.

James O'Reilly is also a director in the company Superior Pipeline Products Limited, a company registered in Ireland and the UK registered company Superior Pipeline Products (UK) Limited.

During the year Superior Pipeline Products Limited charged an amount of €131,218 (2024: €153,380) to Superior Pipeline Products (UK) Limited for the supply of goods in the normal course of business. Superior Pipeline Products Limited also charged a management fee of €17,750 (2024: €32,568) to Superior Pipeline Products (UK) Limited during the year.

At the year end Superior Pipeline Products Limited is owed an amount of €60,022 (2024: €86,957) from Superior Pipeline Products (UK) Limited. This has been included in the trade debtors balance at the year end.

James O'Reilly is also a director in the company Mains2meters Limited, a company registered in Ireland. Both companies belong to the same group with Superior Pipeline GHC Limited as their parent company.

During the year Superior Pipeline Products Limited charged an amount of €11,528 (2024: €17,372) to Mains2meters Limited for the supply of goods in the normal course of business.

At the year end Superior Pipeline Products Limited is owed an amount of €310 (2024: €9,162) from Mains2meters Limited. This has been included in the trade debtors balance at the year end.

During the year Mains2meters Limited charged an amount of €72,211 (2024: €17,179) to Superior Pipeline Products Limited for the supply of goods in the normal course of business.

At the year end Superior Pipeline Products Limited owes an amount of €18,074 (2024: €7,377) to Mains2meters Limited. This has been included in the trade creditors balance at the year end.

During the year Mains2meters Limited advanced €500,000 to the company and this amount remained outstanding at year end. The loan is interest free, unsecured and repayable on demand.

The company operates out of Unit 6/7 Osberstown Industrial Park, Osberstown, Naas, Co Kildare. The premises is owned by James O'Reilly, director. The company has entered into a lease agreement in 2024 for 10 years with an annual rent of €96,000.
