Opinion

NOTES TO THE ABRIDGED FINANCIAL STATEMENTS

for the financial year ended 31 July 2023

1. General Information

MTP Management Company Company Limited By Guarantee is a company limited by guarantee incorporated and registered in Ireland. The registered number of the company is 405744. The registered office of the company is Bohan Hyland, Rathgar House, 53A Rathgar Avenue, Dublin 6, Ireland which is also the principal place of business of the company. The principal activity of the company is the management of the common areas of Mill Tree Park, Ratoath, Co Meath. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the year ended 31 July 2023 have been prepared on the going concern basis and in accordance with generally accepted accounting principles in Ireland and Irish statute comprising the Companies Act 2014 and in accordance with the Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland (FRS 102) issued by the Financial Reporting Council

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014.

Income

Turnover comprises the amounts levied for service charges for the year and also the recharge of debt collection costs.

Outstanding Debtors

The directors wish to emphasise that the unit owners are legally bound to pay their service charges. The directors are considering various methods of recovery. It should be noted that the management company can charge interest on outstanding debts, so that no benefit accrues to the owner for delaying payment and the company does not lose any value from the effect of inflation. On this basis no provision for bad debts has been made.

Trade and other receivables

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

Trade and other payables

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

Taxation

The company is a not for profit organisation and as such suffers on corporation tax on its service charge income.

Sinking Fund Contributions

In accordance with Section 19 of the Multi - Unit Developments Act 2011, the company must establish a sinking fund to fund non-routine maintenance and other non-routine costs that may arise from time to time. The Sinking Fund is not guaranteed to cover all unexpected costs of a non-recurring nature. These funds are held in a separate designated bank account and are allocated to a special reserve titled "sinking fund reserve". Sinking fund contributions are recognized as income in the Income and Expenditure account in the period in which large, non-regular repair and maintenance work is undertaken. The company has set up a separate designated bank account.

3. Provisions Available for Audits of Small Entities

In common with many other businesses of our size and nature, we use our auditors to prepare and submit companies office returns and to assist with the preparation of the financial statements.

4. Common areas and location

The common areas of the development are located at Mill Tree, Ratoath, Co Meath. As far as the directors are aware the common areas of the development have been transferred to the management company.

5. Service Charges

The service charges for the year are calculated by reference to the budget for the year divided among the units in the development by the appropriate apportionment factors. The company is entitled to receive service charges from 72 units.
