1. These financial statements have been prepared in accordance with UK Generally Accepted Accounting Practice (UK GAAP).

3. Hope for Justice Company Limited by Guarantee ("HFJ CLG") is a micro company incorporated in March 2021 and is now a registered charity, as of August 2025. HFJ CLG has not received any donations or carried out income-generating activities as of yet as, following registration, it has been revising the strategy and organising the various elements to commence projects locally. The expenses incurred by HFJ CLG have been paid by Hope for Justice UK ("HFJ UK", a charity registered in England and Wales (No. 1126097) and in Scotland (No. SC045769) and a company limited by guarantee, registered in England and Wales (No. 6563365), and such costs written off by HFJ UK.
