





1. General Information

These financial statements constitute the individual financial statements of EFC Registrars Limited the "Company") for the year ended 30 June 2025.

The financial statements have been prepared in Euros (€) which is also the functional currency of the Company.

2. Statement of compliance

The entity financial statements comply with Financial Reporting Standard 105 "The Financial Reporting Standard applicable to the Micro-Entities Regime". The Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 105).
