(a) Basis of Accounting

The financial reporting framework that has been applied in their preparation is the Companies Act 2014 & FRS 102 The Financial Reporting Standard applicable in the UK

& Republic of Ireland (frs 102) as adapted by Section 1A of FRS 102 and the requirements

of the Companies Act 2014.

The financial statements are prepared in Euro's which is the Functional currency of the

Company. Monetary amounts in these financial statements are rounded to the nearest €

The Financial Statements have been prepared under the historical cost convention and

comply with the financial reporting standards of the Accounting Standards Board.

(b) Taxation

Corporation Tax is calculated after Capital Allowances at the normal rates.

(c) Fixed Assets & Depreciation

Fixed assets are stated at cost less accumulated depreciation, Depreciation is calculated

at 12.5% on a straight line basis.

(d) Turnover

Turnover represents amounts invoiced to customers, exclusive of VAT.
