Opinion

In our opinion the directors are entitled under section 352 of the Companies Act 2014 to annex the abridged financial statements to the annual return of Stefan Burke MB Company Limited by Guarantee ('the company') and those abridged financial statements have been properly prepared pursuant to the provisions of section 353 of that Act (exemptions available to small companies).

Basis of opinion

We have examined :

- (i) the abridged financial statements for the financial year ended 31 July 2025 on pages 8 to 10 which the directors of Stefan Burke MB Company Limited by Guarantee propose to annex to the annual return of the company; and
- (ii) the financial statements to be laid before the Annual General Meeting, which form the basis for those abridged financial statements.

We have audited the financial statements of Stefan Burke MB Company Limited by Guarantee ('the company') for the financial year ended 31 July 2025 which comprise the Income and Expenditure Account, the Balance Sheet, the Cash Flow Statement and the related notes to the financial statements, including the summary of significant accounting policies set out in note 2. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland", issued in the United Kingdom by the Financial Reporting Council, applying Section 1A of that Standard.

In our opinion the financial statements:

NOTES TO THE ABRIDGED FINANCIAL STATEMENTS

for the financial year ended 31 July 2025

1. General Information

Stefan Burke MB Company Limited by Guarantee is a company limited by guarantee incorporated and registered in Ireland. The registered number of the company is 723944. The registered office of the company is 2 Brighton Lane, Monkstown, Co. Dublin which is also the principal place of business of the company. The company continues on a volunteer bases to provide a support to Stefan Burke.

The main object for which the Company is established is to form a Microboard of committed family and friends who join together with Stefan to help him plan his life using a person-centred approach, to access funding and to provide support services to Stefan.

Subsidiary Objects are objects incidental and ancillary to the attainment of the Main Object, the Company shall have the following subsidiary objects:

- Stefan's Microboard will access funding and provide support services to Stefan
- All Planning and decisions undertaken by Stefan's Microboard will demonstrate regard for his Safety, Comfort, and Dignity, with consistent respect of his Needs, Wishes, Interests and Strengths.
- Stefan's Microboard business will be conducted with mutual respect, cooperation, and collaboration.
- Stefan's Microboard will establish and maintain a Personal Support Network for and with Stefan.
- Stefan's Microboard can become an employer responsible for hiring and overseeing staff, and/or contract for services such as supported livings and supportive employment.
- Stefan's Microboard will complete a comprehensive plan to submit to the HSE or any other relevant government body or agency.
- Stefan's Microboard will manage, supervise/monitor and evaluate his needs and outcomes of his Direct/Individualised Funding
- Stefan's Microboard will provide support, information and advice to assist him to make informed decisions.
- Stefan's Microboard will help him to plan his life, brainstorm ideas and problem solve, advocate with him and for him, contact his wider community and monitor, evaluate services he receives and ensure he is safe and financially secure.

Currency

The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the financial year ended 31 July 2025 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" Section 1A, issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1A of FRS 102.

Taxation

The Company is involved in mutual trading activities on which there is no charge to corporation tax.

3. Provisions Available for Audits of Small Entities

In common with many other businesses of our size and nature, we use our auditors to assist with the preparation of the financial statements.

4. Employees

The average monthly number of employees, including directors, during the financial year was Nil (2023: Nil),

5. Status

The liability of the members is limited.

Every member of the company undertakes to contribute to the assets of the company in the event of its being wound up while they are members, or within one financial year thereafter, for the payment of the debts and liabilities of the company contracted before they ceased to be members, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributors among themselves, such amount as may be required, not exceeding € 1.27.

6. Capital commitments

The company had no material capital commitments at the financial year-ended 31 July 2025.

7. Post-Balance Sheet Events

The business plan has been submitted to the Department of Health for funding of Stefan's plan to have a home of his own with support.

8. Approval of financial statements

The financial statements were approved and authorised for issue by the board of directors on 27 March 2026.
