
These financial statements have been prepared in accordance with the Micro Companies Regime.

Notes to the abridged financial statements Financial year ended 15 December 2025

1. General information

The financial statements comprising the Balance Sheet, and the related notes constitute the individual financial statements of Gilroy Gannon Secreterial Services Ltd for the Financial year ended 15 December 2025. Gilroy Gannon Secreterial Services Ltd is a private company limited by shares (registered under Part 2 of Companies Act 2014), incorporated and registered in Ireland (CRO number 573769). The Registered Office is Gilroy Gannon, Stephen Street, Sligo which is also the principal place of business of the company.

Currency

The financial statements have been presented in the Euro currency (€) without rounding.

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 (the Act) and "FRS 105 The Financial Reporting Standard applicable to the Micro Companies Regime" issued by the Financial Reporting Council and promulgated by the Institute of Chartered Accountants in Ireland. The company qualifies as a micro company for the period, as defined by Section 280D of the Act, in respect of the financial year and has applied the rules of the 'Micro Companies Regime' in accordance with Section 280E of the Act and FRS 105.

Profit and loss account policy

The company is dormant as defined by section 365 of the Companies Act 2014. The company received no income and incurred no expenditure during the current financial year or prior financial year and therefore no profit and loss account is presented within these financial statements. There have been no movements in equity during the current financial year or prior financial year.

Financial instruments

Ordinary Share Capital

The ordinary share capital of the company is presented as equity.
