### **"General responsibilities**

In preparing these financial statements, the director is required to:

- make judgements and accounting estimates that are reasonable and prudent;
- state whether the financial statements have been prepared in accordance with applicable accounting standards, identify those standards, and note the effect and the reasons for any material departure from those standards; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The director is responsible for ensuring that the company keeps or causes to be kept adequate accounting records which correctly explain and record the transactions of the company, enable at any time the assets, liabilities, financial position and profit or loss of the company to be determined with reasonable accuracy, enable them to ensure that the financial statements and Director's Report comply with the Companies Act 2014. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

## NOTES TO THE ABRIDGED FINANCIAL STATEMENTS

for the financial period from 13 May 2024 (date of incorporation) to 30 June 2025

### 1. General Information

RPJ Aesthetics & Beauty Limited is a company limited by shares incorporated and registered in Ireland. The registered number of the company is 763818. The registered office of the company is Landscape House, Baldonnell Business Park, Baldonnell, Dublin 22, Ireland. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

### 2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

#### Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 105 "The Financial Reporting Standard applicable to the Micro-Entities Regime" issued by the Financial Reporting Council.

The company qualifies as a micro company as defined by section 280D of the Companies Act 2014 in respect of the financial period, and has applied the rules of the 'Micro Companies Regime' in accordance with section 280E of the Companies Act 2014 and FRS 105.

#### Turnover

Turnover is recognised to the extent that the company obtains the right to consideration in exchange for its performance.

Turnover comprises the invoice value of services provided and good supplied by the company.

#### Trade and other creditors

Creditors and accruals are classified as current liabilities if payment is due within one year or less. If not, they are presented as non-current liabilities. Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### Taxation

Current tax represents the amount expected to be paid or recovered in respect of taxable profits for the financial period and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Statement of Financial Position date.

#### Share capital of the company

##### Ordinary share capital

The ordinary share capital of the company is presented as equity.

##### Exceptional item

Exceptional items are those that the directors' view are required to be separately disclosed by virtue of their size or incidence to enable a full understanding of the company's financial performance.

**4. Going concern**

The company made a loss after taxation of €9,378. This results in net liabilities as at the 30th June 2025 of €9,377. The balance sheet deficit was financed by a directors' loan. The loan is unsecured, interest free and repayable on demand. On that basis the financial statements are prepared on a going concern basis. The financial statements include no adjustments to write down assets to their recoverable amounts or to provide for the costs associated with a cessation of trade, should the company be unable to continue as a going concern.

**5. Post-Balance Sheet Events**

There have been no significant events affecting the company since the financial period-end.

The financial statements were approved and authorised for issue by the board on 29 January 2026.
