## **pursuant to section 356(1) and 356(2) of the Companies Act 2014**

### **Opinion**

In our opinion the directors are entitled under section 352 of the Companies Act 2014 to annex the abridged financial statements to the annual return of Albany House Owners Management CLG ('the company') and those abridged financial statements have been properly prepared pursuant to the provisions of section 353 of that Act (exemptions available to small companies).

### **Basis of opinion**

We have examined :

## NOTES TO THE ABRIDGED FINANCIAL STATEMENTS

for the financial year ended 30 April 2025

### 1. General Information

Albany House Owners Management CLG is a company limited by guarantee incorporated and registered in Ireland. The registered number of the company is 583667. The registered office of the company is Sherry FitzGerald Lettings, 9 Priory Office Park, Stillorgan Road, Blackrock, Co Dublin which is also the principal place of business of the company. The company is a 'not for profit' entity and is responsible for the management, insurance and maintenance of Albany House development located at Killiney Hill Road, Killiney, Co Dublin. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

### 2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

#### Statement of compliance

The financial statements of the company for the financial year ended 30 April 2025 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

#### Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" Section 1A, issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1A of FRS 102.

#### Income

Service charges and levies are accounted for on a receivable basis.

Deposit interest is accounted for on a receipts basis.

Expenses include VAT, where applicable, as the company cannot reclaim it.

#### Trade and other debtors

Trade and other debtors are initially recognised at transaction value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

#### Cash at bank and in hand

Cash at bank and in hand comprises cash at bank and demand deposits with banks.

#### Trade and other creditors

Trade and other creditors are initially recognised at transaction value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### Taxation

Corporation tax is payable on deposit interest where the tax liability is greater than €32.

#### Sinking Fund Contributions

In accordance with Section 19 of the Multi - Unit Developments Act 2011, the company must establish a sinking fund to fund non-routine maintenance and other non-routine costs that may arise from time to time. The Sinking Fund is not guaranteed to cover all unexpected costs of a non-recurring nature. These funds are held in a separate designated bank account and are allocated to a special reserve titled "sinking fund reserve". The company has set up a separate designated bank account, and contributions have been made to same. Further transfers may be made to the sinking fund from liquid resources in each financial period.

### 3. Going concern

The Board have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future. The company therefore continues to adopt the going concern basis in preparing its financial statements.

### 4. Provisions Available for Audits of Small Entities

In common with many other businesses of our size and nature, we use our auditors to assist with the preparation of the financial statements and the submission of the annual return.

### 5. Common areas and location

The common areas in the development have not yet been transferred to the company.

### 6. Service Charges

There are 20 units in the development. Service charges are charged to these units on the basis of the budget agreed by the Board of Directors, approved at AGM and charged to each unit under the terms of their title documents.

### 11. Capital commitments

The company had no material capital commitments at the financial year-ended 30 April 2025.

### 12. Related party transactions

In addition to the annual management fee, the managing agent, Petra Management Limited, charged €977 for repairs and maintenance services (30 April 2024 - €182), €370 for postage and stationery (30 April 2024 - €370), €160 for emergency cover (30 April 2024 - nil) and €230 for company secretarial services (30 April 2024 - €230).

### 13. Controlling interest

The company is controlled by the members. The directors are appointed by the members of the company to run its affairs on their behalf. Each unit owner is a member of the company and each has one vote at all general meetings.

### 14. Post-Balance Sheet Events

There have been no significant events affecting the company since the financial year-end.

### 15. Sinking fund

The company has separate sinking fund deposit account as required by the Multi-Unit Developments Act 2011. The balance in the sinking fund bank account was €2,006 at financial year end (30 April 2024 - €2,000).

The sinking fund provision for the financial year was €1,000 (30 April 2024 - €1,000).

€6,000 is due for transfer to the sinking fund bank account as soon as the cash position of the company allows.

### 16. Managing agent

Sherry FitzGerald Lettings was appointed management agent to replace Petra Management Limited on 1st May 2025.

### 17. Approval of financial statements

The financial statements were approved and authorised for issue by the board of directors on 19 January 2026.
