Opinion

NOTES TO THE ABRIDGED FINANCIAL STATEMENTS

1. General Information

Lakefield eTechnologies Limited is a company limited by shares incorporated and registered in Ireland. The registered number of the company is 244429. The registered office of the company is Unit 3 North Point House, North Point Business Park, New Mallow Road, Cork which is also the principal place of business of the company. The principal activity of the Company consists of software development and sale of software solutions to the utility industry. There has been no significant change in this activity during the year.

The Company's parent company was acquired by Lime Daross Limited on 2 October 2009. Subsequently, the Lime Daross Limited shareholding was acquired by Trimble Navigation Limited on 4 March 2010. The Company significantly improved profitability during the year and continues to monitor its growth strategy to ensure that its long term plans remain on track.

Trimble Inc has issued a letter of support that they will assist us in meeting our liabilities should we not be able to pay them for 12 months after the accounts are signed. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the financial year ended 4 March 2023 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" Section 1A, issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1A of FRS 102.

Turnover

The Company's revenue is derived from product licence fees and charges for services.

Systems integration services derived from long-term contracts are recognised on the percentage of completion method for individual contracts. Revenues are recognised in the ratio that costs incurred bear to the total estimated contract costs, taking into account progress towards reaching a point where experience is sufficient to estimate the final results with reasonable accuracy. Changes in job performance, estimated profitability, and contract settlements may result in revisions to costs and income in the period in which the revisions are determined. Where professional services relate to software licences requiring significant production, modification or customisation of software and the circumstances are such that it is not reasonable to account for the licence element separately, then the entire arrangement will be accounted for as a long-term contract. Professional services which are provided on a time and materials basis are recognised in the period that the services are provided.

Full provision for losses arising is made immediately upon such losses being foreseen

Tangible assets and depreciation

Tangible assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible assets, less their estimated residual value, over their expected useful lives as follows:

Long leasehold property	-	12.5% Straight line
Plant and machinery	-	33% Straight line
Fixtures, fittings and equipment	-	12.5% Straight line
Computer Equipment	-	33% Straight line

The carrying values of tangible fixed assets are reviewed annually for impairment in periods if events or changes in circumstances indicate the carrying value may not be recoverable.

Trade and other debtors

Trade and other debtors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest method less impairment losses for bad and doubtful debts except where the effect of discounting would be immaterial. In such cases the receivables are stated at cost less impairment losses for bad and doubtful debts.

Borrowing costs

Borrowing costs relating to the acquisition of assets are capitalised at the appropriate rate by adding them to the cost of assets being acquired. Investment income earned on the temporary investment of specific borrowings pending their expenditure on the assets is deducted from the borrowing costs eligible for capitalisation. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

Employee benefits

The company operates a defined contribution pension scheme. The assets of the scheme are held separately from those of the company in an independently administered fund. The company also operates a defined benefit pension scheme for its employees providing benefits based on final pensionable pay. The assets of this scheme are also held separately from those of the company, being invested with pension fund managers.

Taxation and deferred taxation

Current tax represents the amount expected to be paid or recovered in respect of taxable profits for the financial year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Balance Sheet date.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at that date that will result in an obligation to pay more tax in the future, or a right to pay less tax in the future. Timing differences are temporary differences between the company's taxable profits and its results as stated in the financial statements.

Deferred tax is measured on an undiscounted basis at the tax rates that are anticipated to apply in the periods in which the timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantively enacted by the Balance Sheet date.

Foreign currencies

Monetary assets and liabilities denominated in foreign currencies are translated at the rates of exchange ruling at the Balance Sheet date. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated at the rates of exchange ruling at the date of the transaction. Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. The resulting exchange differences are dealt with in the Profit and Loss Account.

Research and development

Research expenditure is written off to the Profit and Loss Account in the financial year in which it is incurred.
